Appendix A: Process for determining Senate's jurisdiction

Definitions:

“authority”: refers to the power granted by the University to either the Senate or another body to approve decisions.

“consult/consultation”: a process whereby the Senate or an appropriate standing committee gives feedback to another body or a non-approving body.

“approve/approval”: refers to the Board of Governors or the Senate having responsibility and authority to make final decisions.

If the Senate has authority to approve, it will be forwarded to the University Secretary to bring the matter to the Senate Governance Committee.
